**2017 SCHOLARSHIP APPLICATION INSTRUCTIONS**

The Santa Barbara Women Lawyers Foundation issues a number of scholarships each year of varying amounts (\$1,500 - \$3,500) to law students of **all genders**.

Scholarship applicants are evaluated based on a multitude of factors, including, but not limited to, academic achievement; commitment to the Santa Barbara community; service to the community at large; promotion of gender equality; and plans for utilization of a law degree. The committee may also consider financial need as an additional factor, however the scholarships are open to applicants of all socioeconomic backgrounds and financial need is a requirement for only one of the several scholarships issued.

Please note that the Foundation reserves discretion to direct the scholarship funds to the student's law school, the student himself/herself, or to law student-related necessities such as bar preparation courses, books, etc.

Please complete the questions listed below fully (typed) and submit either: 1) a hard copy, executed original, postmarked by **January 31, 2018**; or 2) a PDF emailed as an attachment to [sbwlfoundation@gmail.com](mailto:sbwlfoundation@gmail.com) to be received by 6:30 p.m. on **January 31, 2018**.

In addition to the questions listed below, please provide the following **mandatory** items when submitting your application:

- Your resume;
- Copy of your law school transcript (if available);
- Copy of your undergraduate transcript (only if law school transcript not available);
- Between two (2) and four (4) recommendation letters from individuals who have known you for at least one year; and
- A personal statement of not more than one page, in 12 point times new roman font, single spaced, that includes something about you personally (background; family; hobbies; business, professional, community or school activities in which you have been involved); any personal and/or professional challenges you have experienced in life, including overcoming obstacles related to socioeconomic and/or educational disadvantage; any activities involving the advancement of women or women's rights; your connection to Santa Barbara County; and your short and long term goals upon successful completion of law school and the bar examination.

Please note that phone or in person interviews will take place during the month of February 2018, between 4 p.m. and 7 p.m. Scholarships will be awarded in March 2018 and recipients will be invited to attend a scholarship luncheon to honor their achievement.
